1. Emergency Communications Procedure

In the event of an emergency or critical incident situation (CODE RED) such as a building lock-down or fire alarm that may occur at 4809 Clio Road, the Flint Department of Health and Human Services (DHHS) will notify Boji Group property management in the following manner.

Phone Call – The DHHS will notify the Boji Group property management contact via phone call. Upon receipt of call, Boji Group shall be responsible for the dissemination of this information to employees or service contractors at its discretion.

In the event of a non-threatening event (CODE ORANGE) that may occur at 4809 Clio Road, the DHHS will notify Boji Group property management in the following manner.

Email Message – The DHHS will notify the Boji Group property management contact via email with any event information deemed significant to the situation. Upon receipt of this message, Boji Group shall be responsible for the dissemination of this information to employees or service contractors at its discretion.

In the event of a building management event (CODE YELLOW) such as a power outage or building closure due to weather conditions that may affect 4809 Clio Road, the DHHS will notify Boji Group property management in the following manner.

Email/Text Message – The DHHS will notify the Boji Group property management contact via email and/or text with any building management events. Manner of notification will depend upon the time sensitivity of the event. Upon receipt of this message, Boji Group shall be responsible for the dissemination of this information to employees or service contractors at its discretion.
